

## Field Crops

Field crops are also important in Oswego County agriculture. The primary types are forage and grains, some of which are not sold, but used on the farm. The sales value of these crops is over \$4.8 million.

## Honey & Maple Syrup

Maple syrup and honey in Oswego County are valued at \$169,000.

About 3,500 gallons of honey and 18,000 pounds of maple syrup are produced in the county each year.



## Christmas Trees

The county's Christmas tree farms produce around 15,000 Christmas trees on average, representing a \$400,000 value in sales.



## Greenhouse & Nursery



Oswego County is also home to a thriving commercial horticulture industry that produces greenhouse and nursery crops. The annual revenue generated by this sector is at least \$2.5 million.

## Strong Markets



Oswego County boasts abundant opportunities for direct marketing, allowing for consumers to buy local, seasonal food directly from a farmer. There are many active CSAs, farmers' markets, and farm stands throughout the county and region. It is no wonder then that the value of food sold directly to consumers has increased by almost 78% since 2012.

Oswego County also boasts strong markets for value-added products, such as maple syrup, honey, fruit wines and juices, beer, cider, dairy products, and organic products.

## Agriculture in Oswego County

Agriculture in Oswego County is diverse and significant, with 612 farms, 1,038 producers, and 86,167 acres of farmland. The unique soil types and climate allow for a wide variety of agricultural production that impacts the economy, with leading products including onions, apples, berries, sweet corn, dairy, field crops, greenhouse and nursery products, and Christmas trees.

Farms in Oswego County also spend more than \$35 million a year on farm production expenses, much of which goes into the local or regional economy.

## Vegetables

Oswego County is well-known for its muck soil-reliant root vegetable industry. Muck soils are high in organic matter, which is ideal for the production of onions, carrots, potatoes, and other root vegetables.

Vegetable farms are by nature very capital intensive and produce a very high-value crop. The majority of the root vegetables grown are exported to other parts of the state and country. The presence of the root vegetable industry has led to spin-offs like packing and shipping operations, which encourages further job creation and tax revenue for Oswego County.

There are also other vegetable crops produced on upland soils in Oswego County, including asparagus, cabbage, sweet corn, peppers, tomatoes, squash, and pumpkins. The wide range of vegetables produced in Oswego County is done so on over 2,400 acres, amounting to more than \$11 million in annual sales revenue and ranking 13th in the state.



## Fruits, Nuts & Berries

Oswego County has a healthy and growing fruit, nut and berry industry. Much like vegetable crops, fruits and nuts are very labor and capital intensive to produce, but extremely high in value. Apples are the most-produced tree fruit in the county and represent the highest volume of sales, with pears following behind. The county's apple growers use the latest high-density planting systems and produce the vast majority of their fruit for fresh market sales.

The climate in Oswego County is difficult for stone fruit production, with little over 11 acres of peaches, plums and cherries. Berry crops grown in Oswego County include blueberries, strawberries, raspberries, elderberries, cranberries, and others.

Oswego County is ranked 22nd statewide for the production of fruits, nuts, and berries, with annual sales revenues from berries and fruit/nut trees totaling over \$600,000 and \$1.3 million, respectively.



## Dairy & Livestock

Dairy farms in Oswego County manage over 4,000 dairy cows combined and generate roughly \$15.5 million annually from the sale of milk.

Livestock production is another important sector of agriculture in Oswego County. Beef cattle, sheep, sows and feeder pigs, goats, elk, alpacas, and poultry are all raised on Oswego County farms.

## Equine

Oswego County ranks 17th in the state for equine, with over 50 horse stables and around 960 horses and ponies, an annual value of \$449,000.
